The proposals will be evaluated on using two stage system with stage one focusing on mandatory requirements, and stage two focusing on responsiveness to the functionality criteria as outlined in the bid document. Bidders who fail to obtain a minimum of <b>70</b> points out of <b>100</b> points for functionality will not be considered further.</p> <p><b>The Department of Public Works and Infrastructure commits itself to the advancement of Broad Based Black Economic Empowerment (B-BBEE) imperatives and thus, the successful bidders will be required to employ 60% black youth towards contributing to job creation.</b></p> <p>A compulsory clarification meeting, will take place at <b>Cnr.
