The bid will be evaluated on Method 2 Functionality, Financial Offer and Preference:

The points scored for price will be added to the points scored for B-BBEE status level of contribution to obtain the bidder's total points scored out of 100 in accordance with the PPPFA and the Preferential Procurement Regulations, 2017.
