(CSD Master Registration Number or copy of registration (Deeds Registration) or Sales Agreement of the building which is exchanging hands and Certified copies of Directors' Identity Documents. The building must be within the geographic boundaries specified in the bid documents in Welkom Matjhabeng Local Municipality The size of accommodation offered may not be less than the minimum lettable area specified in the bid documentation.
