(Where consortium / joint venture / sub-contractors are involved, each party to the association must submit a separate valid tax clearance certificate or a unique security personal identification number).</li> <li>❖ A valid Proof of Registration on the National Treasury's Central Supplier's Database must accompany this bid (A copy with a valid CSD Master Registration Number – MAAA number must be attached).</li> <li>❖ A tenderer with a minimum of B-BBEE level three (3) of contributor or higher, i.e. Only B-BBEE Certificate Level 1, 2 and 3 contributor will be considered.
