(Where Consortium / Joint Venture / Sub-contractors are involved, each party to the association must submit a separate Valid Tax Clearance Certificate or a unique security personal Identification number).</li> <li>❖ A valid Proof of Registration on the National Treasury's Central Supplier's Database must accompany this bid.</li> <li>❖ Potential Bidders must be registered as CIDB <b>Grading Level 8GB. 7GB Potentially Emerging Enterprises who satisfy criteria stated in the Tender Data may submit Tender offers.</b> (Valid proof must be attached).</li> <li>❖ A minimum of B-BBEE level three (3) of contribution certificate or higher, i.e. B-BBEE Certificate Level 1, 2, and 3 contribution.
