(Valid proof must be attached)(Valid proof must be attached) ❖ Attach a proof of qualifications for an installation technician who is accredited by the SAQCC GAS as qualified Gas Practitioner. The accreditation certificate (certified copy) must be active and not older than 3 years. ❖ A minimum of B-BBEE level one (1) of contribution certificate i.e. B-BBEE Certificate Level 2 or less will not be considered. The points scored for price will be added to the points scored for B-BBEE status level of contribution (Maximum of 20 points) to obtain the bidder's total points scored out of 100 in accordance with the PPPFA and the Preferential Procurement Regulations, 2017.

A compulsory clarification meeting, will take place **at the proposed building, Ratlou Complex at Thaba Nchu on Friday, 15 February 2019 starting at 10h00. Failure to attend this clarification meeting will lead to disqualification.**
