A valid CSD master registration number must be provided to that effect.</li> <li>❖ Potential Bidders must have a contractor registered at CIDB Grading Level of <b>8 GB or higher</b> as part of their team. <b>7 GB PE</b> Contractors who meet the criteria in the tender document may also submit bids. (Valid Proof must be attached).</li> <li>❖ Pre-qualification criteria in line with the PPR of 2017: <ul style="list-style-type: none"> <li>➢ A minimum of B-BBEE level one (1) of contribution certificate or higher, i.e. B-BBEE Certificate Level 2 contribution and below will not be considered. (Where trust, consortium or joint venture (including unincorporated consortia and joint ventures) must submit a consolidated B-BBEE Status Level Verification Certificate for every separate tender. An original or certified copy of the original must be attached.</li> <li>➢ Only tenderers subcontracting a minimum of 30% of the contract value (scope of works) to the following enterprises. <ul style="list-style-type: none"> <li>▪ Minimum 25% of contract value must be sub – contracted to EMEs or QSEs which are at least 51% owned by black people. The points scored for price will be added to the points scored for B-BBEE status level of contribution (Maximum of 20 points) to obtain the bidder's total points scored out of 100 in accordance with the PPPFA and the Preferential Procurement Regulations, 2017.
