A valid CSD master registration number must be provided to that effect. ❖ Potential Bidders must have a contractor registered at CIDB Grading Level of 6GB or higher as part of their team. (Valid Proof must be attached). ❖ Pre-qualification criteria in line with the PPR of 2017: <ul style="list-style-type: none"> ○ A minimum of B-BBEE level one (1) of contribution certificate or higher, i.e. B-BBEE Certificate Level 2 contribution and below will not be considered. (Where trust, consortium or joint venture (including unincorporated consortia and joint ventures) must submit a consolidated B-BBEE Status Level Verification Certificate for every separate tender. An original or certified copy of the original must be attached. ○ Only tenderers subcontracting a minimum of 30% of the contract value (scope of works) to the following enterprises. <ul style="list-style-type: none"> ▪ Minimum 25% must be sub – contracted to EMEs or QSEs which are at least 51% owned by black people. Preference will be given to Free State based contractors on CIDB grading level 3 to 6 in various categories of works). ▪ Minimum 5% must be sub – contracted to Contractor Development Programme who are appointed under the CDP programme of the Department. ▪ Bidders must complete and sign declaration for sub – contracting to indicate the percentage of the project value they are committing for sub – contracting purposes. The bid will be evaluated on Method 2 Functionality, Financial Offer and Preference:

Level of Contribution towards B-BBEE	20

The points scored for price will be added to the points scored for B-BBEE status level of contribution (Maximum of 20 points) to obtain the bidder's total points scored out of 100 in accordance with the PPPFA and the Preferential Procurement Regulations, 2017.
